

Chicago Flu Update

What is the risk?

Currently, the risk of influenza infection remains elevated but continues to decrease. Vaccination is the best way to protect against influenza infection and all Chicagoans aged six months and older are encouraged to get vaccinated. Chicagoans should ask their healthcare provider or pharmacist about vaccine availability. For those without a healthcare provider or whose healthcare providers do not have the influenza vaccine, a list of <u>City of Chicago Fast-Track Immunization Clinics</u>¹ is available on the City website and by calling 311. Are severe cases of influenza occurring?

The Illinois Department of Public Health (IDPH) has issued <u>influenza testing and reporting recommendations</u>². Suspected novel and variant influenza, pediatric influenza-associated deaths, influenza-associated ICU hospitalizations and outbreaks of influenza-like illness in a congregate setting should all be reported to CDPH via <u>IN-EDSS</u>³. For the week of April 10-16, 2016 (week 15), 2 influenza-associated ICU hospitalizations were reported (**Figure 1**).

Since October 4, 2015, 254 influenza-associated ICU hospitalizations have been reported; 243 were positive for influenza A (8 H3N2, 133 (H1N1)pdm09 and 102 unknown subtype [subtyping not attempted or not all subtypes tested]) and 11 was positive for influenza B. One hundred twenty-five (49%) were non-Hispanic Black, 144 (57%) were male, and 150 (59%) were 50 years of age or older (median age of 54 years with a range of 3 months-99 years). Seventy-six (30%) had reported lung disease (e.g. asthma, COPD), 65 (26%) had active cardiac disease and 72 (28%) required ventilator support. Seventeen deaths were reported among ICU admissions. Five outbreaks consisting of two or more confirmed cases of influenza were reported in long-term care facilities.

How much influenza-like illness is occurring?





Figure 2. Percent of <u>emergency department</u> visits attributed to influenza-like illness based on manual reporting as determined by individual hospitals, Chicago, by week, for the current season (2015-2016) and previous three seasons, October-May.

CDPH receives data from influenza surveillance sites across Chicago, which report the total number of patient visits seen weekly, and of those visits, the number with influenza-like illness (ILI) (i.e., fever of 100°F or greater, with cough or sore throat). All hospitals in Chicago that provide emergent care are required to report on a weekly basis the total number of emergency department visits, and of those visits, the number with ILI. For the week of April 10-16, 2016 with 10 hospitals reporting, 3.3% of emergency department visits were due to ILI (Figure 2).






Figure 4. Percent of medically attended outpatient visits attributed to influenza-like illness as reported by ILINet facilities, Chicago, by week, for the current season (2015-2016) and the previous three seasons, October-May.

ESSENCE is an electronic syndromic surveillance system that utilizes emergency department chief complaint data submitted daily by participating Chicago hospitals. ILI activity is determined solely based on the patient's chief complaint and does not take into account the entire medical record, as the ILI activity reported in Figure 2 does. Currently, 10 Chicago hospitals submit data to ESSENCE. For the week of April 10-16, 2016, **1.5%** of emergency department visits were due to ILI (**Figure 3**).

in CDC's Influenza-like Illness Surveillance Network (ILINet) by reporting on the number of patients with ILI seen weekly. From April 10-16, 2016, with 23 facilities reporting, 4.2% of visits were due to influenza-like illness (Figure 4).

Which influenza strains are circulating?

Data on influenza virus test results are reported by Chicago laboratories performing influenza subtyping. For the week of April 10-16, 2016, with 6 laboratories reporting, 22 of the 569 (4%) specimens tested for influenza were positive (13 A (H1N1)pdm09, 0 A (H3N2), 0 A [unknown subtype] and 9 influenza B). Since October 4, 2015, 1,469 of 17,876 (8%) specimens tested for influenza have been positive; 1,370 typed as influenza A (39 H3N2, 1,097 (H1N1)pdm09, 234 unknown subtype [subtyping not attempted or not all subtypes tested]) and 99 were typed as influenza B (Figure 5). The cumulative percent of specimens testing positive for influenza is lower than last season during the same time period (Table 1).
