This year the Chicago Department of Public Health (CDPH) has partnered with the Chicago Park District so that any individual who receives a flu shot at a CDPH influenza vaccination clinic receives 200 Park Points[©] from the Chicago Park District. Vaccination is the best way to protect against influenza infection and all Chicagoans aged six months and older are encouraged to get vaccinated. Chicagoans should ask their healthcare provider or pharmacist about vaccine availability. For those without a healthcare provider or whose healthcare providers do not have the influenza vaccine, a schedule of City of Chicago influenza vaccination clinics¹ is available on the City website and by calling 311. What is the risk?

Currently, the risk of influenza infection is low.

Are severe cases of influenza occurring?

For the week of October 29-November 4, 2017, no influenza-associated ICU hospitalizations were reported. The percentage of influenza A associated ICU hospitalizations that were subtyped has steadily increased from 48% in 2010-2011 to nearly 60% in 2016-2017 (**Figure 1**). Subtyping influenza A viruses is important in understanding the overall burden of these subtypes on the population.


Which influenza strains are circulating?


Data on influenza virus test results are reported by Chicago laboratories performing influenza RT-PCR. For the week of October 29-November 4, 2017, with 6 laboratories reporting, 5 of the 513 (<1%) specimens tested for influenza were positive (4 A (H3N2) and 1 influenza B) (**Figure 2**).


Since October 1, 2017, 13 of 2,531 (<1%) specimens tested for influenza have been positive; 11 typed as influenza A (9 H3N2, 2 unknown subtype [subtyping not performed or not all subtypes tested]) and two typed as influenza B.

How much influenza-like illness is occurring?

CDPH receives data from several hospitals in Chicago that provide emergent care, which report on a weekly basis the total number of emergency department visits, and of those visits, the number with influenza-like illness (*fever of 100°F or greater and cough and/or sore throat*). Influenza-like illness is not lab-confirmed influenza, but is used to Figure 1. monitor emergency department and doctor's office visits for people with flu-like symptoms.


For the week of October 29-November 4, 2017, with eight hospitals reporting, 2.3% of emergency department visits were due to ILI (Figure 3).




Figure 4. Percent of medically-attended **outpatient** visits attributed to influenza-like illness as reported by ILINet facilities, Chicago, by week, for the current season (2017-2018) and previous three seasons, October-May.

In addition to emergency departments, several outpatient clinics throughout Chicago participate in CDC's Influenza -like Illness Surveillance Network (**ILINet**) by also reporting on a weekly basis the total number of outpatient clinic visits, and of those visits, the number with influenza-like illness (ILI). For the week of October 29-November 4, 2017, with 22 facilities reporting, 1.5% of outpatient clinic visits were due to influenza-like illness (**Figure 4**).

ESSENCE is an electronic syndromic surveillance system used to monitor influenza-like illness by utilizing the chief complaints of patients visiting emergency departments. Currently, all Chicago hospitals submit data to ESSENCE on a daily basis, covering every emergency department visit in the city.

For the week of October 29-November 4, 2017, 363 of the 21,792 (1.7%) emergency department visits among the 59 Chicago zip codes analyzed were due to influenza-like illness (ILI). Among age groups, children under five years of age had the highest percentage of visits due to influenza-like illness at 7.9%, followed by those 5-17 years of age at 3.6%; those 18-44, 45-64, and 65 and older were at 1% or less.





Figure 5. Influenza-like Illness (ILI) activity level by patient zip code determined by chief complaint data submitted to **ESSENCE**, Chicago, for week of October 29-November 4, 2017 (week 44).

Figure 5 represents the percentage of emergency department visits due to influenza-like illness aggregated by patient zip code. For the week of October 29-November 4, 2017, 46 of 59 (78%) zip codes had ILI activity levels in the minimal to low categories and 13 (22%) had ILI activity levels in the moderate to high categories; the median percent ILI was 1.4% with a range from <1% to 4.4% (**Figure 6**).



Where can I get more information?

Reporting Information

The Illinois Department of Public Health (IDPH) has issued influenza testing and reporting recommendations⁶; healthcare facilities can report
