

This project is installing a new residential street lighting system in the 44th Ward on Melrose, School, Henderson, Roscoe, and Newport from Southport to Racine. It's part of Aldermanic Menu Program. B.O.E. will supply davit poles and luminaires which City Lights will install. City Lights will supply helix foundations, piggyback fixtures, handholes, directional bore conduit, and supply all material and equipment needed. .

The Bureau of Electricity had planned to do this project with City Forces, but due to our work load, we can't do it in a timely manner.
