



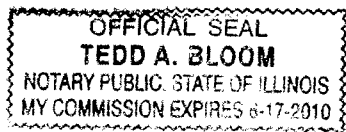

Old Town Pocket Parks-Wells St. electrical repairs involve repair of in-street duct banks for power to the Old Town Pocket Parks.

This electrical extra is needed due to unforeseen conditions found in the field that differ from the construction drawings. This project is related to the Old Town Pocket Parks, and is time sensitive for completion this construction season.
