1. Please describe the major features of this project.

Alderman Laurino requested that CDOT build an earthen berm at Monticello Avenue and North Branch of the Chicago River. The berm is designed to reduce the possibility of flooding whenever the river level rises due to heavy rains. The 3 ft high berm consists of a granular base and top soil with Geogrid material and drought resistant plantings. This item of work could not be performed by City Forces and is not covered by an existing term agreement or the landscaping JOC contract with Seven-D-Construction Co.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

The project entails a relatively small scope of work. It would not be time or cost effective for the work to be performed through the City's traditional bid process.
