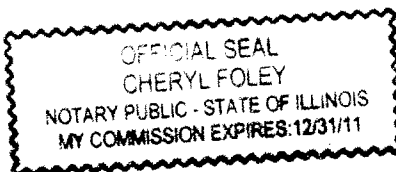

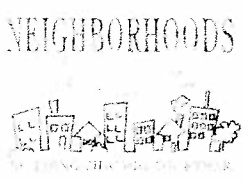

Dear Mr. Sullivan:

We have been requested to submit an invoice for the installation of the decorative Christmas Lights in the 26th Ward for Alderman Billy Ocasio. We have completed the testing and repair of the lights in our shop. We have completed the installation on the city light poles, and tested the existing cable and made all necessary repairs. All of the lights are operational at this time. We were requested to include the cost for the removal of the lights when the Alderman directs us to and the crating of the lights for storage.

The cost for the above referenced work is **\$33,000.00.**

On December 27, and 31 we were called out to repair and relocate 8 fixtures by the alderman's office. The cost for this work was **\$4,650.00** which is not included in the above amount.

This price does not cover any maintenance costs for the system during the time they are operational.

This project is installing festival lighting in the 26th Ward on Division from Western to Kedzie.

The Bureau of Electricity had planned to do this project with City Forces, but due to our work load, we can't do it in a timely manner. The Bureau of Electricity can't use the traditional bid process because of the time frame involved. The Bureau of Electricity established JOC to help us manage these situations when they occur.
