This letter responds to your letter dated November 4, 2014 seeking certain information regarding the entities holding equity interests (either directly or through a subsidiary) in LMG2, LLC ("LMG2"). While LMG2 is not under an obligation under the Concession Agreement or otherwise to provide the City with information regarding the ownership interests of each of its Members, LMG2 is nonetheless providing the City with that information in furtherance of the ongoing settlement discussions between the parties and subject to the protections for Confidential Information set forth in the parties' Confidentiality Agreement. As such, attached to this letter is a schedule of the Members of LMG2 and each of their percentage equity interests as of November 10, 2014. As the schedule shows, no single Member holds a majority voting or economic interest. Further, each Member has confirmed that there are no agreements, understandings or arrangements between or among any of the members relating to its acquisition of ownership interests in LMG2 or the exercise of its ownership rights in LMG2, and that each such Member is acting independently in such regard. For the avoidance of doubt, there has not been a Change in Control as that term is defined in the Concession Agreement.

In addition to invoking the protections for Confidential Information under the Confidentiality Agreement for the information set forth in this letter and the attached schedule, LMG2 also hereby invokes all applicable protections from disclosure provided by the Illinois Freedom of Information Act, 5 ILCS 140, and expressly states that this information constitutes

confidential and proprietary trade secrets and/or commercial or financial information and that disclosure of this information may cause competitive harm.

As a related matter, the information provided to the City in Melanie Walker's October 21 email to Wes Hanscom also was provided in the context of the parties' settlement discussions and pursuant to the Confidentiality Agreement, as the email expressly stated. That information also constitutes Confidential Information pursuant to the terms of the Confidentiality Agreement and should be treated as such. In the future, to the extent you include such Confidential Information in any correspondence or other document, please make it clear that the information is confidential and was provided in connection with settlement communications. Please confirm your agreement to do so.

We also note that the City has shared Confidential Information with Mr. Yonover, who was copied on your November 4, 2014 letter, and Kim Cook, who was copied on an email replying to Ms. Walker's email. We trust that the City is taking all appropriate steps to ensure that these two individuals, as well as anyone else with whom LMG2's Confidential Information is being shared, is bound to and abiding by the Confidentiality Agreement. Please confirm.





C. 


